### **LES and Covid**

- The beauty of Loleta Union Elementary has been shining through with the latest weather. We have had a lot of rain (and only one leak in the roofs which Cas fixed immediately thank you very much!) but as the sun has come out it has shown off the landscaping and colors of the land as we prepare for winter. We give thanks to having such a beautiful place to have our school.
- It is with great sorrow that we have had to say good bye to our lovely lady of the harvest, Patti Collins. She has decided that she is needed full time at home with the upcoming birth of her second grandchild. We will miss her dearly.
- Trunk and Treat/Halloween went extremely well! Thank you Dan and the Student Support Team for the lovely decorations!
- The Harvest festival also went extremely well. Around 200 people came and supported the school and the LCRC. There were tables from Open Door, Smile Humboldt, Centro De Pueblo and many others to help support our community. The 7th and 8th grade team were there selling vegetables and the PTO was selling Cougar jackets. Thank you for your time to support the school. The LCRC provided free tacos from a taco truck and Centro De Pueblo had its dance group perform for the community. On Saturday there were classes on making lotions from natural sources and other cultural events. Our corn was the featured food that day!
- Girls basketball went on despite the extra precautions put in place for covid.
   Athletes have to get tested weekly and be negative to play. The mask mandate has been lifted for indoor sports, however, student athletes, coaches and support staff if unwilling to wear a mask, will be required to test twice a week. Boys basketball has begun practicing!.
- I was successful in reporting out for the 3 grants and applying for the new one.I
   will keep you all updated as to their progress for bringing in more money.
- The Book Fair was an amazing success this year! Thank you all for your support! We brought in \$1800.00 approximately and this qualified us for a 40% return to us. With around \$650 we bought books and items for the Cougar Cash store. The students are thrilled!

- The Kiwanis deserve a big thank you for purchasing some of our pumpkins with a huge donation of \$260 which will to to 7/8th grade! They have also donated 4 bicycles. After Thanksgiving break we will be running a raffle for them. 10 pieces of cougar cash to get a raffle ticket. ### Updates and Announcements.

### Socio-Emotional Learning and PBIS:

Sandy shared that Loleta Elementary School is doing well with Socio-Emotional Learning with Monday Zoom assemblies for all grade levels and behavior management with the support of the Student Services Support Team. Students are making progress with Positive Behavior Interventions and Supports (PBIS) clear expectations and reinforcement with Cougar Cash. New teachers are working out well and making relationships with students and families. Current focus is on reading intervention including tutoring in the classroom.

### Student Store:

Sandy asked about possible fundraising efforts and community donations for the Student Store. Autumn shared that the recent Book Fair at LES generated \$1200 in funds to purchase items for the Student Store. Crystal asked about PTO fundraising and asking local stores for donations. Rose shared that True North is applying for a grant to create a community school. Autumn is applying for a MTSS grant thay may be able to fund the Student Store and positive outings for students.


### **Loleta Elementary School School Climate Report**

### **Socio-Emotional Learning:**

This school year, LES is implementing components of the *CharacterStrong* curriculum. Each month, LES teachers will be implementing lessons in the classroom based on the character trait of the month. On Mondays, a school assembly is held by Zoom from K-4th graders and 5th-8th graders where the character trait is taught through videos and a powerpoint discussion. The theme for November is Gratitude. The Powerpoints can be accessed here:

### Positive Behavior Interventions and Supports (PBIS):

School wide PBIS expectations are taught every Monday during the school assembly. Expectations have focused on the bus, cafeteria, bathrooms, cell phones, conflict resolution, and when someone feels like they are being bullied. Teaching expectations is a key component of PBIS with positive reinforcement offered in the form of "Cougar Cash". Students are excited to purchase items in the Cougar Store every week and a monthly raffle. Some teachers are also utilizing classroom based reinforcement strategies in their classrooms.





### Appropriate Language At School Code Switching

Adults who lack social skills or impulse control skills could be fired from a job for using inappropriate language. They could also experience relationship problems if they offend others with their words.

Do you know the saying, "If you can't say anything nice, don't say anything at all"?

Code switching means using language appropriate for the time and place. For instance, you would not use inappropriate language around your grandparents or at school in front of adults and other students, especially those younger than you.


